- No. 2** All pets must comply with the following specifications (documentation from an accredited veterinarian must be provided by Guest upon request.
- a. May not exceed 40 lbs
 - b. Must be at least 3 years old
 - c. Must be spayed or neutered
 - d. Must be up-to-date on rabies vaccinations and all other vaccinations. Heartworm preventive is highly recommended.
- No. 3** Property is fenced in, however, Guest assume complete responsibility for Pets. Pets should be leashed at all time. San Manuel, AZ Law states if you are walking your dog, the dog must be on a leash at all times.
- No. 4** Guest are responsible for cleaning up any/all pet refuse. If pet refuse is left on the property there will be additional \$150.00 charge for clean up.

- No. 5** Pet/s are not allowed on furniture at any time. Any evidence of pets on furniture there will be additional \$150.00 charge.
- No. 6** All pet/s are to be treated with a topical flea and tick repellent three (3) days prior to arrival. Fleas and ticks are very rampant in this area and can cause harmful/fatal illness to humans and pets. If there is evidence of fleas in the Rental Home there will be additional \$350.00 charge for fumigation.
- No. 7** Pet/s must not cause damage to premises or furnishings. If damages are caused, the cost of the damage will be deducted from security deposit and the remainder of cost charged to Guest.
- No. 8** Guest should prevent pet/s from producing excessive noise at a level that disturbs the neighbors, or violates Town/City Ordance.
